TERMS & CONDITIONS

- 1. The Procuring Agency has the right to reject all bids as per provisions of PPRA Rule 33.
- 2. Procedure of open competitive bidding will be single stage two envelope in accordance with PPRA Rules 36(b). One main envelope should contain two separate sealed envelopes marked as technical and financial bids.
- 3. Financial bids of technically qualified bidders will only be opened. Financial bids will be returned unopened to the technically unqualified bidders.
- 4. The amount of the bid must be in Pak rupees. The language of the bid is English and alternative bids shall not be considered. The bid validity period shall be 90 days.
- 5. The rate quoted shall correspond to 100% of the requirements specified in Annexure-B and must remain valid for 12 months.
- 6. Bids must be inclusive of all applicable taxes and the same will be deducted as per prevailing rules of FBR.
- 7. The bids received after the due date and time will not be entertained.
- 8. In light of PPRA Rule 18, NESPAK shall disqualify Property Agents/Owners if it finds at any time that the information submitted by the Landlords/Property Agents/Owners is false and materially inaccurate.
- 9. Sealed bids must be submitted on or before **January 22, 2024** at **given address.** Technical bids will be opened on the same day on 1430hrs in the presence of bidder or their representatives who may choose to attend.
- 10. The most advantageous bidder shall be engaged in an agreement.
- 11. The envelopes shall be clearly mentioned, "Confidential only to be opened by the authorized person(s)".
- 12. The building being offered must be free of encumbrances and from all types of litigation.
- 13. Previous utilities bills of the building must be paid by the owner prior to signing of lease agreement.
